# **EVV Program Implementation Timeline**



Innovations, TBI Waiver, and (b)(3) Services

January 1, 2021

March 31, 2021

Managed Care State Plan PCS (Medicaid Only) July 1, 2021

□ During the first 90 days following launch, NC Medicaid will operate EVV as "Pay and Report." This means claims will not pend based on failed validation. NC Medicaid will give providers from Jan. 1, 2021, through close of business March 31, 2021, to adjust to EVV implementation. During this period, if a claim fails validation the system will generate a report of the validation issue and allow the provider to cure the issue. If the validation issue is not resolved and cured in 90 days, the payment may be subject to recoupment.

NC Medicaid will go-live with EVV on January 1, 2021. On Jan. 1, 2021 all providers subject to EVV are required to capture visits through their selected EVV solution. While we understand training during the Holidays has posed challenges to agencies ensuring all staff are trained, it is NC Medicaid's expectation that by no later than Jan. 31, 2021 agencies are capturing visits for <u>all</u> beneficiaries through EVV. Providers who are not capturing all visits by Jan. 31, 2021 may be subject to recoupment of claims paid for the period EVV data was not captured.

□ The Cures Act excludes live-in paid caregivers from verifying in-home personal care visits. To ensure those waiver participants are not subject to the requirements under EVV, the CAP/C and CAP/DA plans of care (POC) live-in status section must be updated to indicate the waiver participant who only receives personal care services (in-home aide, pediatric nurse aide, personal assistance, respite and congregate services) from a paid live-in caregiver.

Span Dating Ends Jan. 1, 2021 for Providers Subject to Electronic Visit Verification

- To comply with the EVV requirements, each in-home visit must receive a validation of the core components of EVV. To ensure that each claim line complies with the EVV requirements, the "From (date of service)" and "To (date of service)" field on each claim line must be the same or the claim line will deny.
- Because each date of service billed must be validated to ensure that an EVV record is on file for that specific date of service, it is necessary to bill each date of service as a separate claim detail line.



#### **PROVIDER EVV SELECTION & TRAINING REQUIREMENTS**


□ If your agency has not enrolled with Sandata or a third-party alternate EVV vendor by Dec. 18, 2020, your agency will be required to enroll with Sandata for the initial EVV launch. After initial launch, a change to an alternative EVV vendor can be made. Providers are to ensure there is no disruption in visit capture during the transition.
